Indonesia Program:
Build Change's Indonesia team relocated from Aceh to West Sumatra in 2008 to provide hands-on technical assistance to homeowners who lost their houses in the March and September 2007 earthquakes there. The region was hit by another strong earthquake in September 2009. None of the houses that Build Change had assisted with prior to that earthquake sustained any damage.

Since 2009, Build Change has partnered with members of the emergency capacity building consortium under funding from USAID OFDA and with other non-profit relief agencies to provide technical assistance and training to builders, technical facilitators and homeowners as they rebuild permanent houses with cash grant funding from the Indonesia government. Build Change has also begun and sustained a vocational school training program in the region providing earthquake-resistant housing training to thousands of vocational school students.

China Program:
Build Change's team of Chinese construction professionals provided technical assistance and training to homeowners, builders, engineers and government officials rebuilding houses after the devastating May 12, 2008 earthquake in Sichuan, PRC and then transitioned to providing training courses for technical colleges and government officials to help institutionalize safe construction practices. Its program there was wound down in the Summer of 2011 as reconstruction efforts were essentially completed.

Haiti Program:
Build Change began its Haiti program following the catastrophic earthquake there on January 12, 2010. Initially, with funding from USAID OFDA, Build Change built and trained a team of Haitian construction professionals to provide technical assistance and training to government engineers, relief agency staff, local builders and homeowners. In 2011, while efforts on that initial program were completed, Build Change began partnering with a large number of additional non-profit agencies working in the region to rebuild or retrofit houses damaged in the earthquake. In addition, Build Change provides technical training on earthquake-resistant construction techniques to various non-profits, government officials, engineers, builders and homeowners.
